In addition, the Limited Warranties do not include a warranty of uninterrupted or error-free operation of the EP Cube Product, and do not cover costs related to the removal, installation, or trouble-shooting of electrical systems. The Limited Warranties also do not cover (a) superficial defects, coating, painting, dents or marks that do not impact the performance of the EP Cube Product, (b) noise or vibration that is not excessive or uncharacteristic and does not impact product performance, or (c) LED indicator failure that does not affect product operation.

REMEDIES

If an EP Cube Product fails to conform to the Limited Performance Warranty or the Limited Product Warranty during the applicable Warranty Period, CSI Solar will, at its option, either repair the Product, replace the Product with a product of the same type (or equivalent type if the same type is not then available), or refund the appropriate residual market value of the Product.

Unless otherwise required by any mandatory applicable law, the Limited Warranties do not cover any transportation costs for returned products or parts, or for reshipment of any repaired or replaced product or parts, or any other cost associated with installation, removal, or re-installation of products or parts.

Any repair or replacement of an affected EP Cube Product shall not increase the applicable Warranty Period. The Warranty Period for replaced or repaired product is the remainder of the Warranty Period for the original affected EP Cube Product. Ownership of all products and parts which have been replaced is passed to CSI Solar.

Subject to the terms, conditions and exclusions contained below, and subject to the EP Cube Products remaining connected to the Internet following installation, CSI Solar Co., Ltd. ("CSI Solar") warrants to the original end user buyer (the "Buyer") that EP Cube Products shall during the applicable Warranty Period be free from defects in materials and workmanship that have caused an adverse effect on product functionality under normal application, installation, use, and service conditions as specified in CSI Solar's standard product documentation, such as the installation manual and its annexes (the "Limited Product Warranty"). The Warranty Period under this Limited Product Warranty for EP Cube Products other than Accessories shall be ten (10) years, and the Warranty Period for EP Cube Accessory Products shall be two (2) years, in each case starting from the Warranty Effective Date identified below.

Claims under the Limited Product Warranty can only be accepted if the Buyer can prove that the malfunctioning or non-conformity of an EP Cube Product has resulted exclusively from defects in materials and/or workmanship under normal application, installation, use and service conditions as specified in CSI Solar's standard product documentation.
